3.1 PRESENTATION ON THE REQUEST FOR DISPOSAL OF STATE-OWNED PROPERTIES FOR A GAS PLANT – ALTERNATIVE ENERGY SUPPLY AND SUSTAINABLE HUMAN SETTLEMENTS AND PROVISION OF STUDENT CITY (PRECINCT)


EXCO resolved: That it: -

- a) Approves the disposal by way of donation of three state owned properties for the purposes of developing an alternative energy supply – being a gas plant, to the North West Development Corporation (40 hectares from Ptn 13 Wildbeestpan 442 IP; 20 hectares from Ptn 7 of the farm Rooderand 46 JQ and the full extent of Ptn 115 Rietvly P (measuring 2.5696 hectares).
- b) Approves the donation of portion 412 Vythoek 428 IQ, for the creating of sustainable human settlements to the JB Marks Local Municipality.
- c) Approves the donation of Portion 132 of the Farm Town and Townlands Mmabatho 301 JO, comprising of 42 hectares to the North West Housing Corporation (NWHC) for the purpose of development of a smart city (student precinct).
- d) Endorses that a suspensive condition be inserted on the title deeds of the properties to be disposed to the entities to ensure that they utilise the land for the purpose it was sought for.
- e) Directs that the identified and donated properties **MUST NOT** be sold and should be used for the purpose for which it was donated for (Student city/precinct, Gas to energy and human settlements).

f) Directs that a final report be submitted to EXCO after the disposal of these properties.

Further resolved: That:-

g) The Department of Public Works & Roads should ensure compliance with applicable legislation and regulations for disposal of the land.
